# SUBJECT: EGCP-3 "LS" and "MC" product discontinue notification and last time buy



This announcement is used to inform Woodward Customers, Channel Partners and Sales & Marketing of the product rationalization and product support plan for EGCP-3 product line. The Woodward EGCP-3 "LS" and EGCP-3 "MC" controls are important product lines to Woodward. However due to acute obsolescence of important components; Woodward is forced to cease production of these devices in the near future. Woodward has produced and supported this product line for many years and will continue to offer new sales of this product line in the short run, and support for them in the long run. Please refer to the below support schedule.

#### Woodward offers the following "Last Time Buy (LTB)" scenario:

- Orders for the Last Time Buy can be placed until 21<sup>st</sup> December 2012.
  Woodward will accept orders until this date. We ask our customers to make preparations to apply the items listed in Section Replacement Items on the next page.
- We will conduct a price increase of 25% on the items listed under *Discontinued Items* effective from 01<sup>st</sup> January 2013
- Woodward will ship items ordered on or before the LTB date until 31<sup>st</sup> March 2013 based upon the LTB volumes. After this date Woodward will stop the production.
